- 1 The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on 10th August, 2013
- 2 The Company has only one reportable business segment, namely, Drugs & Pharmaceuticals.
- 3 On December 7, 2012, the management of the Company had entered into certain agreements with Otsuka Pharmaceutical Factory, Inc., Japan Otsuka and Mitsui & Co. Ltd., Japan (Mitsui) for transfer of its Infusion Business to Claris Otsuka Limited on a slump sale basis. The Company has received necessary approvals from its shareholders and regulatory authorities and transfer was completed on July 31, 2013. Post transfer, the Company holds 20% of equity share capital of Claris Otsuka Limited. The Company operates under a single business segment, and in view of common employees, marketing expenses, logistics and distribution arrangements and general corporate overheads, which are not separately identifiable for identified products of the infusion business which has been transferred, the Company is unable to determine the income and expenses clearly attributable to the discontinuing operation. Under the facts and circumstances, the Company is unable to disclose separately the profit from the continuing and discontinuing operations, tax expense of discontinuing operations and profit from discontinuing operations after tax.
